## PrimeXBT "Trade as VIP" Terms and Conditions

#### 1. Introduction

- 1.1. These "Trade as VIP" Promotion Terms and Conditions (hereinafter the "Promotion Terms") apply to the promotional campaign titled "Trade as VIP 30 Days of Top-Tier Trading" (the "Promotion"), offered by PrimeXBT (Pty) Ltd, an authorised financial services provider in South Africa with license number 45697, with registration no. 2013 / 099697 / 07 and having its registered address at 180 Lancaster Road, Gordons Bay, Gordons Bay, Western Cape, 7140 (hereinafter "PrimeXBT", the "Company", "we", "us", or "our"). PrimeXBT (PTY) LTD acts as an intermediary between the investor and the market maker which is the counterparty to the products purchased through PrimeXBT.
- 1.2. By participating in the Promotion, you fully and unequivocally accept these Promotion Terms, the General Terms & Conditions of the Company (hereinafter the "Company Agreement"), and all relevant policies (collectively referred to as the "Terms"). The latest versions of these documents are available at any time under the Legal Documents section on the PrimeXBT Website (<a href="https://primexbt.com">https://primexbt.com</a>) (hereinafter the "Website"), as amended from time to time.
- 1.3. These Promotion Terms serve as a supplement to the Company Agreement. In the event of any inconsistency between the Promotion Terms and the Company Agreement, the latter shall prevail.
- 1.4. The Promotion and all PrimeXBT products and services are not available to any person who resides in a restricted jurisdiction or to a US Reportable Person, as defined in the Company Agreement.
- 1.5. The Client acknowledges and agrees that the availability of certain products, platforms, bonuses, promotions, and services may be restricted or unavailable in certain jurisdictions, subject to the Company's sole discretion.

- 2.1. The Promotion shall commence on 1 July 2025 and shall remain in effect until 31 August 2025, unless amended, extended, suspended, or terminated earlier at the sole discretion of the Company.
- 2.2. Each newly registered Client will be granted VIP 2 status for a period of thirty (30) consecutive calendar days, starting from the date of account registration on the PrimeXBT platform. Thereafter, the account will revert to the default (non-VIP) fee structure unless the Client qualifies for a VIP Tier under the standard VIP Tiers Program.

- 2.3. The Promotion applies exclusively to trading on the PXTrader platform and the Crypto Futures platform.
- 2.4. The Promotion does not apply to MetaTrader 5 (MT5) accounts.

## 3. Eligibility

- 3.1. The Promotion is available exclusively to newly registered, verified Clients of PrimeXBT who are not residents of restricted jurisdictions, as determined at the Company's sole discretion.
- 3.2. Clients must meet and maintain all onboarding, KYC, and compliance requirements under the Company Agreement in order to remain eligible.
- 3.3. The Company reserves the right, at its sole discretion, to decline, suspend, restrict, or revoke a Client's eligibility for or participation in the Promotion at any time and without prior notice, including but not limited to cases where the Company reasonably suspects that the Client has violated these Promotion Terms, the Company Agreement, any applicable laws or regulations, or has engaged in abusive, fraudulent, deceptive, unethical, or manipulative conduct, or has otherwise acted in a manner that is inconsistent with the spirit, purpose, or fair usage of the Promotion.

#### 4. Requirements and Limitations

- 4.1. VIP status and related benefits granted under this Promotion are applied per individual trading account and are non-transferable.
- 4.2. All fees, benefits, and thresholds associated with the Promotion are subject to change at the sole discretion of the Company, with or without prior notice.
- 4.3. VIP 2 status or any related promotional benefit may not be redeemed for cash or exchanged for any alternative benefit unless explicitly stated by the Company.

#### 5. General Conditions

- 5.1. The Company does not guarantee the uninterrupted availability of the Promotion and may modify, suspend, or terminate the Promotion at any time without prior notice.
- 5.2. The Company shall not be held liable for any losses, costs, or damages resulting from participation in, or inability to participate in, the Promotion, including but not limited to those caused by system errors, platform outages, force majeure, or regulatory intervention.
- 5.3. Any attempt to abuse, exploit, or manipulate the Promotion, including but not limited to wash trading, self-trading, or collusion, shall result in immediate disqualification and may lead to account restriction or closure.

- 6.1. PrimeXBT reserves the right to modify, suspend, or cancel the Promotion or these Promotion Terms at any time and for any reason, at its sole discretion.
- 6.2. PrimeXBT reserves the right to disqualify any Client who breaches these Promotion Terms or engages in deceptive, abusive, or fraudulent conduct in connection with the Promotion.

- 6.3. All decisions made by PrimeXBT in relation to the Promotion, including eligibility, application, or termination of benefits, are final and binding.
- 6.4. The Company shall not be responsible for any claims, losses, taxes, or damages incurred as a result of participating in the Promotion, including trading losses, technical faults, or system delays.
- 6.5. By participating in the Promotion, Clients agree to hold PrimeXBT, its affiliates, directors, officers, and employees harmless from any and all liability related to the Promotion or its benefits.
